What is Included?

Important Details

The event site will be open to participants beginning 12 pm on Thursday June 2nd and will need to be cleared by 12 pm June 5th. Eight meals will be provided over the course of the event with the purchase of our food plan: 3 Breakfasts, 2 Lunches, and 3 Dinners. The Saturday evening feast is open and free to all attendees

The Group Site at Osage Hills State Park provides Cabins with bunk style beds that can accommodate up to 12 People. The Cabins are fitted with wall units that provide both Heating and Air Conditioning. Please indicate on Registration forms if you would like to be housed with a specific Group/person. There is a Main Dining Hall and centrally located Bathrooms.

We will be hosting a Silent Auction. If you intend to donate to the Silent Auction please be sure to indicate this on your Registration form.

Every Adult participant is expected to sign up for at least one shift of food preparation or cleanup with the exclusion of Rede Members, Vendors and persons meeting special pre-approved conditions.

Pets are not allowed with the exception of trained animal companions for the disabled.

Not all events will be open-attendance activities. Although we are striving to provide an event that is primarily family friendly, some activities are simply not deemed appropriate for children. Such events will be limited as well as being clearly indicated as such on the Program listing. We welcome the young people of our community!!
